PRINCIPAL REPORT

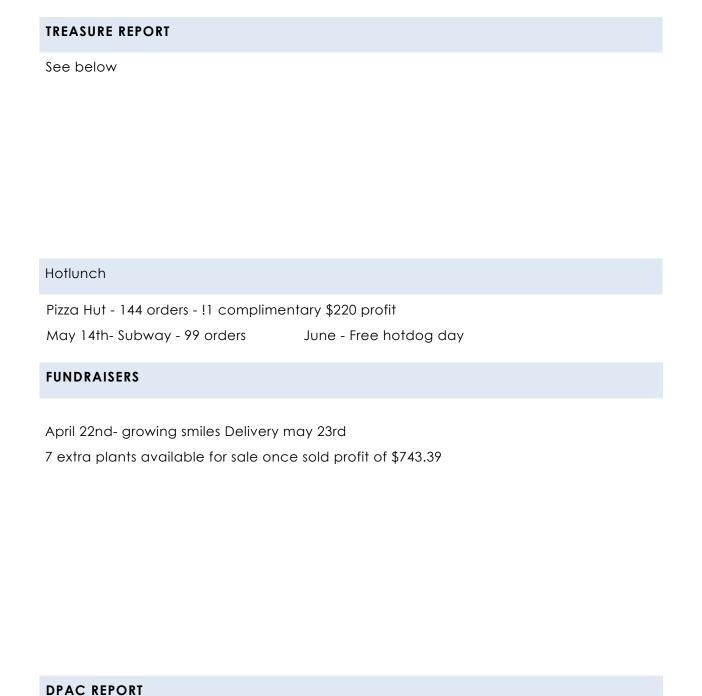
